

# Application for the 2022-2023 Academy for Urban Leadership Charter School Board of Trustees Elections

To be qualified to run for an open position on the Board certain skill sets, commitment, and passion to serving youth must be evident. A board member will ideally have achieved recognition and status within the community, and knowledge about the educational and social concerns of the Perth Amboy community. Specific competencies including the ability to ensure and safeguard the organization's mission and purpose; and enhance the School's public standing.

With this stated, board members will have, at minimum, the following characteristics:

1. A member will assist the Board in achieving demographic goals with respect to age, gender racial, ethnic and income diversity.
2. A member will embody adequate geographic representation of individuals who live and/or work in Perth Amboy.
3. A member will bring areas of expertise or influence of significant benefit to the School; and/or bring in work and organizational experience of significant benefit to the School, particularly with a proven track record as an educator, administrator, executive or other similar position of leadership.

Time commitment:

A Board member is required to attend all regularly scheduled meetings and is expected to be in attendance of special and emergency meetings as they occur. In addition, members are required to attend monthly committee meeting on a regular basis as work vital to the proper functioning of the School occurs at these meetings. **Only if you are certain you can make this important commitment of time should you complete this application.**

**If elected to the Board a member must, by law, submit to a criminal background check and fingerprinting.**
